

THE BUREAU ACCORDING TO JIM

I really don't know how a summer can go by so fast. Last I can recall, we were still planting, and planting, and planting. Now the time is quickly approaching when we'll be gearing up for harvest.

If you've read my column over time, you realize I like agriculture history and Farm Bureau history. Why? Because it is amazing to learn about all the things our forefathers did and created to be more successful, more productive, and more responsible. Take the invention of the hand or thumb peg, for example. Farmers used this tool to help them shuck the corn from the plant and toss it into a horse drawn wagon. It was slow work compared to today, but just think of how much more productive they were by inventing it.

Regarding history and innovation, the Illinois Farm Bureau will be kicking off the celebration of their 100th anniversary at this year's Farm Progress Show. Just thinking about all the history associated with this celebration makes me smile. So many people with a vision have helped to create and continually shape this great organization. Their foresight is nothing less than amazing and we have a strong organization today to prove it. Not only is Illinois Farm Bureau strong but so are all the affiliate companies that were spawned from Farm Bureau to address members' needs.

The following companies (and numerous others that have been disbanded due to their need being fulfilled) created by ILLINOIS Farm Bureau serve members needs daily: COUNTRY Financial, GROWMARK/FS, and Prairie Farms Dairy. These companies and others were formed by IFB for specific member needs that were not being met in any other way.

COUNTRY Financial was started in 1925 to provide farmers with fire insurance on their farms. Since farms were remote and fire services took

so long to get to them, insurance coverage on farm buildings was either impossible to get or so expensive that farmers couldn't afford it. Farm Bureau members directed the organization to find a solution and Farmers Mutual Reinsurance Company was formed to offer affordable fire insurance to members. Today, COUNTRY Financial is among the largest insurance companies in the country and operates in numerous states offering everything from home/farm/auto insurance to life insurance and investment services.

GROWMARK/FS held a similar history. As technology advanced in the early 1920s so did the need for kerosene. Farmers could get the first tractors delivered to their farm but found it nearly impossible to maintain a reliable fuel source to feed the beast. Once again Farm Bureau members called on their organization to find a solution. This was the birth of Illinois Farm Supply Company, better known today as GROWMARK and its FS member companies. From 1927 to present, the farmer owned cooperative has grown from a kerosene supply company into a full service Farm Bureau affiliate offering fuels, seed, fertilizer application, crop protection products, crop advisory services, and more.

Once again as farmers called on Farm Bureau for assistance, the organization responded to the needs of dairy farmers that weren't getting their fair share of the value of the milk they produced. Yet again, a new organization was formed known as the Illinois Producers Creamery, better known today as Prairie Farms Dairy. Its leadership, derived from the very producers it represents, has helped grow the company into the Fortune 500 giant it is today. And yet, it's still a farmer cooperative that shares its profits with the farmers that sell milk

to it.

Many other organizations have been formed by Illinois Farm Bureau to offer members the goods and services they need to maintain a profitable farming operation. Other involvement included the significant role it played to create and initially fund several commodity associations including the Illinois Corn Growers Association, Illinois Soybean Association, Illinois Milk Producers Association, Illinois Specialty Growers Association, and the Illinois Wheat Association.

Well, that's my history lesson for this issue. Don't worry; I don't require readers to take a test on the subject matter. I just hope members realize the rich history and massive influence Illinois Farm Bureau has offered over the past 100 years. If you can't tell, I'm proud of our phenomenal organization and grateful to have worked for it throughout the last 22 years.

One last thing before I let you go. As the busyness of harvest gets underway, please remember one thing: **YOUR SAFETY AND THAT OF YOUR FAMILY AND EMPLOYEES SHOULD BE AT THE TOP OF MIND EVERY MINUTE.** I know as well as any of you that we get focused on the tasks of getting the crop out, but you must constantly remind yourself of safety. One of the least thought of safety issues is fatigue. Just a few more rounds; gonna fill up the trucks first before quitting for the night..... There may be too much at risk if you lose focus because your tired (even if you don't think you are) and someone gets injured or killed in the process. Looking back, no one would ever say, "Well, at least it was worth it." So stay safe and alert. Others in the field or on the road may not, so it's up to you. Have a safe and blessed harvest.

GOVERNMENTAL AFFAIRS

Our committee monitors a lot of legislative / regulatory issues being discussed in their respective bodies of government. There's been a lot going on and nothing going on, both at the same time. Nothing significant is happening regarding negotiations between the

Governor and the Speaker of the House. As long as state employees are able to keep working, the budget impasse will not have nearly the pressure on leaders to resolve the matter. This is obviously good for workers to be able to continue receiving the necessary income to provide for their families, but it takes away the urgency to get a budget agreement.

On the national front, there has been more activity. Even though Congress has been on recess, several issues still keep moving along. The U.S. House passed legislation to create national GMO labeling standards versus the piecemeal of state regulations. This consistency will be good for agriculture and good for consumers. Our thanks to Congressman Rodney Davis for speaking so eloquently

on the House floor to champion the passage of the bill. Section 179 expensing seems to be getting more traction again and may be discussed soon. WOTUS defunding legislation is still on the table but the regulations became effective at the end of August.

Farm Bureau has joined a coalition to change the way legislative districts are drawn every 10 years. We encourage members to stop by our office to sign the petition for placing it on the ballot or contact us and we'll send you a petition form that you may circulate yourself.

As harvest begins, I want to first thank everyone who works to take action when we ask. It's what makes us strong and successful. Secondly, I want to wish everyone safety and success this harvest.

2. Increasing funding and technical support for various state and federal programs to assist farmers, landowners, and drainage districts in controlling erosion and runoff.....
12. Including funding for technical assistance in the overall costs to implement government programs addressing natural resource or environmental issues.
17. Public/private partnerships to provide consumer education programs on conservation programs.

GOVERNMENT ECONOMIC POLICIES

With a national debt over \$18 trillion and a state budget deficit, our governments are facing significant challenges. Farmers are great managers of money and we have always been concerned with this crisis. To help solve the fiscal issues, what do federal and state lawmakers need to do to accomplish our policy?

6. A requirement that federal and state government agencies return unspent money to their respective treasuries without a budget cut or penalty for the new fiscal year.
9. Requiring competitive bidding for any major state or federal project to ensure the most efficient development and construction of those projects.

We will continue to make the adoption of sound economic policies by the state and federal government a major priority. We urge county Farm Bureaus to do likewise.
